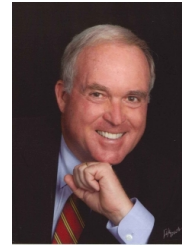

CURRENT I-9 FORM USE IS EXTENDED

Just a few days before the current Employment Eligibility Verification Form I-9 was set to expire, U.S. Citizenship and Immigration Services announced an extension of the current form. In November 2015, USCIS published a notice in the Federal Register informing the public of numerous proposed changes to the form which included computer-friendly features in a revised electronic format. After receiving feedback from the public during the initial comment period, the agency has made further revisions and is seeking additional comments through April 27, 2016. Until these added changes are finalized and the new form is released, the current Form I-9 which contains the expiration date of 3/31/16 should continue to be utilized for employment verification purposes.
